TRANSPARENCY REPORT FOR THE FINANCIAL YEAR 2023 - 2024



Screen Craft Rights (SCR) is a Collective Management Organisation (CMO) representing the interests of UK film and television craft persons in respect of secondary exploitation revenue generated by their respective contributions to scripted audio-visual works when they are exploited abroad.

In accordance with the terms of The Collective Management of Copyright (EU Directive) Regulations 2016 ("the Regulations") the information published here and in associated public documents combine to form the annual transparency report for the year indicated herein.

This Transparency Report should be read in conjunction with the published Financial Report and Accounts, Memorandum and Articles of Association and the Code of Practice, which includes SCR's Distribution Policy. All documents can be found on the SCR website.

European copyright laws recognise Film and Television Directors, Writers and Composers as being authors (rights holders) of their works. Additionally, some countries also recognise the contribution of Cinematographers, Editors, Production Designers and Costume Designers. This recognition can give rise to payment to the UK under some national schemes that compensate such contributors for the exploitation of their work.

Screen Craft Rights is a private company limited by guarantee, has no subsidiary undertakings, and operates on a not-for-profit basis. Its Members are professionals working as one of the following craft disciplines of the audio-visual industry: Film and Television Editors, Cinematographers, Production Designers and Costume Designers.

In the case of the deceased members, Screen Craft Rights admits to membership a single Successor Member nominated by the consent of all the deceased's heirs and such successor is paid on behalf of the deceased's estate for onward distribution in accordance with the applicable testamentary disposition.

SCR is a collective management organisation (CMO) for the purposes of the Regulations and it is governed by its constitutional documents and by an unremunerated Board that is representative of the four different crafts whose work is recognised and rewarded. Additionally, the Board includes two Non-Member Directors with special expertise. The Board Annual accounts are prepared and, once approved, published on the Screen Craft Rights website. Screen Craft Rights is not itself a licensing body. Due to the English legislative framework, Screen Craft Rights neither collects in the U.K. nor distributes abroad any SCR-type royalties.

Payments attributable to UK craftspeople are remitted from abroad to Screen Craft Rights in the UK and the money is allocated to the individuals whose work corresponds to the data provided with the revenue so remitted. Screen Craft Rights' distribution to members occurs annually in October/November. Notwithstanding SCR's own payment cycles, SCR is dependent upon the payment cycles of its partner societies abroad. Consequently, revenue arrives in instalments across two consecutive years of Screen Craft Rights' statutory accounting periods. Receipts can cover revenue received for Members in both the current SCR financial year and the previous one. Thus, while compliant with the Regulations, it is not possible, nor economical to try, accurately to match in a single accounting year the exact receipts in the UK to which the revenue applies.

CHIEF EXECUTIVE'S REPORT ON ACTIVITIES IN THE YEAR

Collections and Distributions

Within its distribution cycle, Screen Craft Rights' revenue was £1,565,752. In total, £1,550,943.41 was distributed to Members during the annual distribution in Autumn 2023. This was Screen Craft Rights largest distribution to date. Unusually, two final payments, for 2017 and 2018, were received from Bild-Kunst in Germany in the same distribution cycle. Going forward, SCR is unlikely to receive more than one final payment within a distribution cycle.

1,649 members received a payment at some point in the year, the majority within the annual distribution.

Membership

By the end of the year, the total membership stood at 2,218. Screen Craft Rights welcomed 241 new members during the year, which was far higher than expected. This reflected the downturn in the industry, where craft authors had the opportunity and the motivation to join Screen Craft Rights.

Change of Leadership

Having helped found Screen Craft Rights in 2011, Suzan Dormer decided to embrace new challenges. David Grindley was appointed Chief Executive in November 2023 and started on 1st January 2024. Suzan Dormer conducted the handover process and officially departed Screen Craft Rights on the 1st February 2024.

Collective Management Organisation (CMO) Partners

Screen Craft Rights has reciprocal agreements with the following CMOs: Bild-Kunst (Germany), VdFS (Austria), Suissimage (Switzerland), Kopiosto (Finland), Norwaco (Norway) and Copyswede (Sweden). Although the United Kingdom's withdrawal from the EU has proved challenging, Screen Craft Rights maintains good relationships with its partners and looks to reinforce its standing by concluding more agreements where possible.

PAYMENTS TO MEMBERS 2023-2024

Screen Craft Rights distributes 100% of revenue received, save for that which is applied to administrative costs. It does not retain any amount for any other purpose.

A percentage of the gross amount received for members is retained to cover administrative costs. The percentage is fixed annually by the Board of Directors.

Any overestimation of the actual costs involved will result in the remaining balance being returned to the Members' Fund at the end of the financial year and then be added to the next distribution of money from the relevant issuing CMO.

The Board of Directors fixed the amount to be withheld for administrative costs at **10%**. At the end of the financial year the company's accountants calculated the net costs to members as being **4.24%**.

£90,241 was returned to the Members Fund, to be added to the 2024-2025 distribution.

AMOUNTS DISTRIBUTED TO MEMBERS BY COUNTRY OF RECEIPT

As individual amounts can sometimes be very small, payments for different uses are combined. This means that members only receive one payment, per work, per country of receipt. This procedure also serves to maintain administrative costs at the lowest level possible.

Amounts below include payments issued in the 2023-2024 main distribution plus payments issued to new members during the year. Some payments will have been received by SCR in previous financial years. These reflect the monies held for new members.

Income generated by Rights Revenue

Interest earned on monies held by Screen Craft Rights pending distribution amounted to **£59,369.45**.

On behalf of the Members, the Board of Directors agreed for the money to be used for approved administration costs. This explains the low net cost to members within this financial year.

Payments not distributed only included:

- 1.those held for non-members for the period specified in the Regulations and in conjunction with the ongoing identification and pursuit of new members.

REPORT OF FACTUAL FINDINGS ON THE AUDIT OF THE TRANSPARENCY REPORT
